Uskon, että näin pystymme välittämään sanomaa siitä, kuinka isoihin asioihin ylioppilaskunta oikeasti vaikuttaa ja kuinka isoja hankkeita saamme aikaan, kun tarpeeksi tahtoa löytyy. Täten viestintä on asia, jonka kehittämiseen haluan erityisesti panostaa edustajiston varapuheenjohtajana.

Ylioppilaskunta on olemassa opiskelijoitamme varten. Pidetään siis huolta, että kurssi pysyy yhteisenä ja yhtenäisenä!
